SENATE BILL NO. 1424

BY FINANCE COMMITTEE

AN ACT

RELATING TO THE APPROPRIATION TO THE OFFICE OF THE STATE PUBLIC DEFENDER;
APPROPRIATING ADDITIONAL MONEYS TO THE OFFICE OF THE STATE PUBLIC DE-
FENDER FOR FISCAL YEAR 2025; REDUCING THE APPROPRIATION TO THE OFFICE OF
THE STATE PUBLIC DEFENDER FOR FISCAL YEAR 2025; AUTHORIZING ADDITIONAL
FULL-TIME EQUIVALENT POSITIONS; EXEMPTING THE APPROPRIATION FROM EX-
PENSE CLASS TRANSFER LIMITATIONS; AND DECLARING AN EMERGENCY AND PRO-
VIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. In addition to any other appropriation provided by law,
there is hereby appropriated to the Office of the State Public Defender the
following amounts to be expended according to the designated expense classes
from the listed funds for the period July 1, 2024, through June 30, 2025:

SECTION 2. Notwithstanding any other provisions of law to the contrary,
the appropriation made to the Office of the State Public Defender is hereby
reduced by \$10,980,500 from the General Fund for trustee and benefit pay-
ments for the period July 1, 2024, through June 30, 2025.

SECTION 3. FTP AUTHORIZATION. In addition to any other authorization
provided in law, the full-time equivalent position authorization provided
to the Office of the State Public Defender is hereby increased by two hundred
ninety-nine (299.00) for the period July 1, 2024, through June 30, 2025.

SECTION 4. EXEMPTIONS FROM EXPENSE CLASS TRANSFER LIMITATIONS. The
Office of the State Public Defender is hereby exempted from the provisions
of Section 67-3511(1) and (3), Idaho Code, allowing unlimited transfers
between expense classes, for all moneys appropriated to it for the period
July 1, 2024, through June 30, 2025. Legislative appropriations shall not be
transferred from one fund to another fund unless expressly approved by the
Legislature.

1 SECTION 5. An emergency existing therefor, which emergency is hereby
2 declared to exist, this act shall be in full force and effect on and after
3 July 1, 2024.
