8 SECTION 2. FTP AUTHORIZATION. In addition to any other authorization 9 provided by law, the full-time equivalent position authorization provided 10 to the Office of the Attorney General is hereby increased by one and four-11 tenths (1.40) for the period July 1, 2024, through June 30, 2025.

SECTION 3. In addition to the appropriation made in Section 1, Chapter Laws of 2023, and any other appropriation provided for by law, there hereby appropriated to the Office of the Attorney General for the Special Litigation Program \$435,000 from the General Fund to be expended for the period July 1, 2023, through June 30, 2024, for trial costs related to the *Tucker v. Public Defense Commission* lawsuit.

SECTION 4. An emergency existing therefor, which emergency is hereby declared to exist, Section 3 of this act shall be in full force and effect on and after passage and approval, and Sections 1 and 2 of this act shall be in full force and effect on and after July 1, 2024.
