- Charges filed by prosecutor
 - Charges may be dismissed, amended or added throughout process
- Initial appearance
 - Bail or detention
 - Pretrial release
- Preliminary hearing (felony only)
- Pretrial conference (misdemeanor)

- Arraignment
 - Charges may be dismissed, amended or added throughout process
 - Charges may be amended
- May plead guilty and eliminate need for a trial
- Trial
 - May be acquitted
 - Convicted of crime

 - May be revoked and underlying sentence executed
- Incarceration
 - Prison or jail
 - Parole (Commission)
 - After prison term and parole hearing
 - Supervised by IDOC
