CONVENED: **Co-Chairman Grow** called the meeting of the Joint Finance-Appropriations Committee (Committee) to order at 8:00 a.m.

LSO STAFF PRESENTATION: **BUDGET SETTING- FY 2025 STATE APPELLATE PUBLIC DEFENDER, LBB 5-9, Tim Hibbard, Analyst, Legislative Services Office (LSO) Budget and Policy Analysis**

Mr. Hibbard presented the FY 25 budget for the State Appellate Public Defender's Office before the Committee. The State Public Defender's Office provides indigent persons in the state of Idaho with capital and appellate representation. The FY 25 budget included one enhancement request for Appellate conflict cost restoration.

MOTION: Moved by **Representative Bundy**, for the State Appellate Public Defender, beginning with the FY 2025 JFAC Maintenance Budget add \$41,600 for appellate conflict costs restoration; and \$58,200 for the 2% CEC. For the State Appellate Public Defender, for FY 2025, a total of \$99,800 from the General Fund; seconded by **Senator Bjerke**.

DISCUSSION: **Mr. Hibbard** provided an explanation of intent language related to the motion. In the prior fiscal year, \$1.3 million was appropriated for costs related to capital cases. Due to unforeseen case loads in the Appellate Representation unit, the agency has requested \$100,000 for appellate representation costs.

INTENT LANGUAGE: SECTION_. REAPPROPRIATION AUTHORITY. There is hereby reappropriated to the State Appellate Public Defender any unexpended and unencumbered balances appropriated to the State Appellate Public Defender from the General Fund for fiscal year 2024, in an amount not to exceed \$1,209,400 from the General Fund for costs directly related to the provision of representation in capital cases, to be used for nonrecurring expenditures for the period July 1, 2024, through June 30, 2025. The Office of the State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative Services Office prior to processing the reappropriation authorized herein.

SECTION_. REAPPROPRIATION AUTHORITY. There is hereby reappropriated to the State Appellate Public Defender any unexpended and unencumbered balances appropriated to the State Appellate Public Defender from the General Fund for fiscal year 2024, in an amount not to exceed \$100,000 from the General Fund for costs directly related to outside counsel for noncapital appeals, to be used for nonrecurring expenditures for the period July 1, 2024, through June 30, 2025. The Office of the State Controller shall confirm the reappropriation amount, by fund, expense class, and program, with the Legislative Services Office prior to processing the reappropriation authorized herein.

LSO STAFF PRESENTATION: **BUDGET SETTING - FY 2025 OFFICE OF THE STATE PUBLIC DEFENDER, LBB 5-105, Tim Hibbard, Analyst, LSO Budget and Policy Analysis**

Mr. Hibbard presented the FY 25 budget before the Committee for the Office of the State Public Defender. This agency is new for FY 25. Previously, the Public Defense Commission provided indigent defense grants to counties. The state elected to create a statewide public defense system. The Maintenance budget included \$13.4 million appropriated for this budget. The FY 25 enhancement requests are operations from the Public Transit Commission.

For the Office of the State Public Defender for FY 2025, \$3,087,600 from the General Fund, and \$35,530,000 from dedicated funds, for a total of \$38,617,600 and an additional 299.00 full-time equivalent positions, seconded by **Senator Cook**.

DISCUSSION: **Mr. Keith Bybee**, Division Manager, LSO Budget and Policy Analysis, clarified budget detail amounts reflect timing considerations from one agency ending and another being created.

SECTION . EXEMPTIONS FROM EXPENSE CLASS TRANSFER LIMITATIONS. The Office of the State Public Defender is hereby exempted from the provisions of Section 67-3511(1) and (3), Idaho Code, allowing unlimited transfers between expense classes, for all moneys appropriated to it for the period July 1, 2024, through June 30, 2025. Legislative appropriations shall not be transferred from one fund to another fund unless expressly approved by the Legislature.
