





CHILDREN'S ADVOCACY CENTER?



01

Child-Focused Facility

Trauma-focused, comfortable and safe - designed to make the process of sharing their account feel the most comfortable.

02

Child Forensic Interview

Trained professionals interview the child with nonsuggestible strategies while partners in law enforcement, child protection services, and medical and mental health provider team members observe and contribute to a collaborative investigative process - while the interview is recorded with specialized equipment.

03

Support & Services

Children only have to tell their account one time at a CAC, and the child and the family have a supportive team to help them through the process.

The Children's Advocacy Center Model is proven to provide better outcomes for children and abuse investigations AND has economic implications for significant cost savings to the state.

Research

Maryland Children's Alliance partnered with the University of Maryland to determine the financial value of the multidisciplinary team response to child maltreatment

Findings

Research found that the average cost to the state for one child who was not served by a MDT was nearly 3 million dollars versus the significant savings of one child maltreatment case being investigated with a MDT/CAC partnership costing just shy of 4,500.

Bottom line estimates of the research state that cost for MDT response to child maltreatment was .15% the cost of a child not served by the MDT. Findings of the research state that for every \$1 the state invests in MDT response to child maltreatment the return on the investment are estimated to be \$663.



DEFINED IN IDAHO CODE

Title 16 - Juvenile Proceedings Chapter 16 - Child Protective Act

(11) "CHILD ADVOCACY CENTER" OR "CAC" MEANS AN ORGANIZATION THAT ADHERES TO NATIONAL BEST PRACTICE STANDARDS ESTABLISHED BY THE NATIONAL MEMBERSHIP AND ACCREDITING BODY FOR CHILDREN'S ADVOCACY CENTERS AND THAT PROMOTES A COMPREHENSIVE AND COORDINATED MULTIDISCIPLINARY TEAM RESPONSE TO ALLEGATIONS OF CHILD ABUSE BY MAINTAINING A CHILD-FRIENDLY FACILITY AT WHICH APPROPRIATE SERVICES ARE PROVIDED. THESE SERVICES MAY INCLUDE FORENSIC INTERVIEWS, FORENSIC MEDICAL EXAMINATIONS, MENTAL HEALTH SERVICES AND OTHER RELATED VICTIM SERVICES.







PROSECUTION


