Council members will be responsible for reviewing existing applications of AI in state government and identify potential state-level AI policies for consideration by the legislature and the governor. Based on the expenditures for prior interim committees, this council is estimated to require \$10,000 from the General Fund for each full year of operation. With the sunset date of January 1, 2027, the total appropriation over the lifespan of the council is estimated at \$25,000 from the General Fund.

DOCKET NO. Amy Lorenzo, Building Construction and Real Estate Bureau Chief, presented the pending rules for **Docket No. 24-0501-2301** relating to Drinking Water and

Wastewater. The pending rule disposes of outdated, duplicative, or created barriers while focusing on consumer protection and safety. The code of ethics was greatly simplified to remove language that could be perceived as a practice standard and this provided clarity for licensees and help remove cumbersome language. They also removed barriers by allowing distance learning opportunities for all of the license types except of back-flow assembly testers. The framework changed to identify a passing score instead of a percentage to provide standardization for the licenser process. There is a new licenser type for a small wastewater distribution

system which was implemented due to feedback from stakeholders.

MOTION: Rep. Furniss made a motion to approve Docket No. 24-0501-2301. Motion

carried by voice vote.

DOCKET NO. Tiffany Floyd, Air Quality Division Administrator, presented the pending rules for **58-0101-2301: Docket No. 58-0101-2301** relating to the Control of Air Pollution in Idaho and the air

quality divisions annual Incorporation by Reference of federal regulations. For DEQ to be implementing authority for the Clean Air Act, they are required to continually demonstrate the air quality program meets minimum federal requirements. This year's incorporation includes changes made to the Code of Federal Regulations (CFR) as of July 1, 2023. EPA also updated regulations for source testing of emissions under various rules. This included correcting typographical and technical errors, updating outdated procedures, and adding clarity and consistency among monitoring requirements. The revisions will improve the quality of data but will not

impose new requirements on facilities, owners, or operators.

MOTION: Rep. Wisniewski made a motion to approve Docket No. 58-0101-2301. Motion

carried by voice vote.

DOCKET NO. Michael McCurdy, Waste Management and Remediation Division Administrator for the Department of Environmental Quality, presented **Docket No. 58-0107-2301**

relating to the rules regulating Underground Storage Tank Systems. There are several sections which were revised to essentially simplify the language and provide clarity by removing outdated, duplicative and unnecessary language. These changes resulted in a reduction of 3,498 words, including 50 restrictive words.

MOTION: Rep. Raybould made a motion to approve Docket No. 58-0107-2301. Motion carried by voice vote. DOCKET NO. Jerri Henry, Drinking Water Protection and Finance Division Administrator with 58-0108-2301: the Department of Environmental Quality, presented Docket No. 58-0108-2301 relating to the Idaho Rules for Public Drinking Water Systems. He stated this docket represents their compliance efforts with the Zero-Based Regulation Executive Order No. 2020-01, or ZBR. The goal of the ZBR effort was to perform a critical and comprehensive review of the entire chapter to reduce overall regulatory burden, streamline various provisions, and increase clarity and ease of use while maintaining state program approval and primacy of the Safe Drinking Water Act. For this rulemaking, they have updated their state rules to adopt by reference the federal regulations without being more stringent. They did not propose any new regulations not regulated by the federal government and no substantive changes were made related to the stringency requirements. They also have adopted the Code of Federal Regulations, as of July 1, 2023, which encompasses the Lead and Copper Rule Revisions that became effective December 2021. Jerri Henry then introduces Tyler Fortunati, Drinking Water Bureau Chief, to provide more information about the pending fee rule. **Tyler Fortunai** talked in depth about fourteen sections of the pending fee rule which were modified to increase clarity and simplification of language. MOTION: Rep. Wheeler made a motion to approve Docket No. 58-0108-2301. Motion carried by voice vote. DOCKET NO. Mary Anne Nelson, Surface and Wastewater Division Administrator with DEQ, 58-0125-2301: presented **Docket No. 58-0125-2301** relating to the Rules Regulating the Idaho Pollutant Discharge Elimination System Program. This docket complies with zero-based regulation review and rewrite of IDAPA 58-0125. The changes resulted in a reduction of over 6,700 words for a total reduction of 11 pages to reduce regulatory overburden. Incorporation by reference which rules have been changed and removed sections duplicative of Idaho Code. General purposes this rulemaking does not impose or increase a fee beyond what has been previously submitted to and reviewed by the legislature, but it is a fee rule. MOTION: Rep. Raybould made a motion to approve Docket No. 58-0125-2301, with the exception of the typographical error on pg. 457 section m. Motion carried by voice vote. functions as a state government entity and its primary focus lies in prioritizing specialization within AI applications while upholding constitutional and legal rights. Furthermore, the council is committed to respecting privacy and confidentiality,

recognizing certain datasets as off-limits for inclusion in databases. The

recommendations put forth by the council are designed to inform policy decisions and guide stakeholders towards ethical Al practices. Acknowledging the importance of oversight, the council has a sunset date, slated to conclude on January 1, 2027, unless legislative extension is warranted due to demonstrable positive outcomes. To effectively execute its mandate, the council requests a budget allocation of

\$25,000, essential for fulfilling its objectives within the Al landscape.

She talked on the reliability of coal and nuclear power plants, highlighting their independence from weather conditions. To illustrate her point, she referenced a notable incident in Texas where wind and solar energy systems faltered for a prolonged period of seventeen days, resulting in significant repercussions, including the loss of two hundred lives.
