BY TRANSPORTATION AND DEFENSE COMMITTEE

AN ACT

RELATING TO RULES OF THE ROAD; AMENDING SECTION 49-666, IDAHO CODE, TO ESTABLISH A CERTAIN EXEMPTION REGARDING SAFETY HELMET REQUIREMENTS AND STANDARDS AND TO MAKE TECHNICAL CORRECTIONS; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

HOUSE BILL NO. 14

BY STATE AFFAIRS COMMITTEE

AN ACT

RELATING TO THE IDAHO CODE CLEANUP ACT; AMENDING TITLE 67, IDAHO CODE, BY THE ADDITION OF A NEW CHAPTER 37, TITLE 67, IDAHO CODE, TO PROVIDE A SHORT TITLE, TO PROVIDE A DECLARATION OF NECESSITY, TO DEFINE TERMS, AND TO REQUIRE STATE AGENCIES TO REVIEW IDAHO CODE AND DELIVER A CERTAIN REPORT; AND DECLARING AN EMERGENCY.
