HOUSE RESOLUTION NO. 4 BY STATE AFFAIRS COMMITTEE

A HOUSE RESOLUTION

STATING FINDINGS OF THE HOUSE OF REPRESENTATIVES AND PROVIDING FOR THE AMENDMENT OF RULE 70 OF THE RULES OF THE HOUSE OF REPRESENTATIVES.

Be It Resolved by the House of Representatives of the State of Idaho:

WHEREAS, the House of Representatives deems it necessary and desirable that Rule 70 of the Rules of the House of Representatives be amended.

NOW, THEREFORE, BE IT RESOLVED by the members of the House of Representatives, assembled in the First Regular Session of the Sixty-eighth Idaho Legislature, that Rule 70 of the Rules of the House of Representatives shall be amended to read as follows:

RULE 70

Admittance to Floor of House. – The following persons shall be admitted to the floor of the House of Representatives during sessions: legislators, elected state officials, former state legislators, legislative employees, and representatives of the news media. In order to be admitted to the floor of the House, elected state officials, former state legislators, legislative employees, and representatives of the news media shall be required to wear badges prepared by the Chief Clerk. Only legislators, legislative employees, and representatives of the news media shall be allowed on the floor of the House while the chamber is conducting business.

Any elected state official or former state legislator must be sponsored by a legislator in order to be admitted to the floor of the House and must leave the floor of the House before the

House commences business unless authorized to remain during business by the Speaker of the House. Any other guest of the House must be cleared through the Speaker of the House, or persons designated by the Speaker, and through the Sergeant at Arms, in order to be admitted to the floor of the House.
