HOUSE BILL NO. 27

BY HEALTH AND WELFARE COMMITTEE

AN ACT

RELATING TO NURSES; AMENDING SECTION 54-1402, IDAHO CODE, TO REVISE A DEFINITION; AND DECLARING AN EMERGENCY AND PROVIDING AN EFFECTIVE DATE.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. That Section 54-1402, Idaho Code, be, and the same is hereby amended to read as follows:

54-1402. DEFINITIONS. As used in this chapter:

(1) "Advanced practice registered nurse" means a registered nurse licensed in this state who has gained additional specialized knowledge, skills and experience through a program of study recognized or defined by the board. An advanced practice registered nurse is authorized to perform advanced nursing practice, which may include the prescribing, administering and dispensing of therapeutic pharmacologic agents, as defined by board rules. An advanced practice registered nurse shall perform only those acts as provided by the board and for which the individual is educationally prepared. Advanced practice registered nurses shall include the following four (4) roles: certified nurse-midwife; clinical nurse specialist; certified nurse practitioner; and certified registered nurse anesthetist as defined in board rule. An advanced practice registered nurse collaborates with other health professionals in providing health care.

(2) "Board" means the board of nursing.

(3) "Licensed practical nurse" means a person licensed by the board who practices nursing by:

(a) Functioning at the direction of a licensed registered nurse, licensed advanced practice registered nurse, licensed physician, or licensed dentist in a role falling within the nurse's scope of practice as defined by the board;

(b) ~~Contributing to the~~ Performing delegated assessments of the health status of individuals and groups of individuals;

(c) Participating in the development and modification of the strategy of care;

(d) Implementing the appropriate aspects of the strategy of care as defined by the board, including administering medications and treatments as prescribed by those health care providers authorized to prescribe medication;

(e) Maintaining safe and effective nursing care rendered directly or indirectly;

(f) Participating in the evaluation of responses to interventions; and

(g) Delegating nursing interventions that may be performed by others and that do not conflict with this chapter.

(4) "Licensed registered nurse" means a person licensed by the board who practices nursing by:

5 (c) Establishing goals to meet identified health care needs;
6 (d) Planning a strategy of care;
7 (e) Prescribing nursing interventions to implement the strategy of

9 (f) Implementing the strategy of care, including administering medi-
10 cations and treatments as prescribed by those health care providers au-
11 thorized to prescribe medication;
12 (g) Authorizing nursing interventions that may be performed by others
13 and that do not conflict with this chapter;
14 (h) Maintaining safe and effective nursing care rendered directly or
15 indirectly;
16 (i) Evaluating responses to interventions;
17 (j) Teaching the theory and practice of nursing;
18 (k) Managing the practice of nursing; and
19 (l) Collaborating with other health professionals in the management of
20 health care.

21 (5) "Nursing education program" means a course of instruction offered
22 and conducted to prepare persons for the practice of nursing, or to increase
23 the knowledge and skills of the practicing nurse.

24 (6) "Practice of nursing" means the performance by licensed practi-
25 cal nurses, registered nurses and advanced practice registered nurses of
26 acts and services that require formal nursing education and specialized
27 knowledge, judgment and skill, which acts and services assist individuals,
28 groups, communities and populations in order to promote, maintain or re-
29 store optimal health and well-being throughout the life process. Nursing
30 practice encompasses a broad continuum of services delivered in health care
31 and non-health care environments for remuneration or as volunteer service.
32 Nursing practice may be clinical as well as nonclinical in a variety of ar-
33 eas including, but not limited to, education, administration, research and
34 public service. Nursing practice occurs at the physical location of the
35 recipient.

36 SECTION 2. An emergency existing therefor, which emergency is hereby
37 declared to exist, this act shall be in full force and effect on and after
38 July 1, 2025.
