A JOINT MEMORIAL

1 TO THE PRESIDENT OF THE UNITED STATES, TO THE MAJORITY AND MINORITY LEADERS  
2 OF THE UNITED STATES SENATE, AND TO THE CONGRESSIONAL DELEGATION REPRESENTING THE STATE OF IDAHO IN THE CONGRESS OF THE UNITED STATES.

5 We, your Memorialists, the House of Representatives and the Senate of  
6 the State of Idaho assembled in the First Regular Session of the Sixty-eighth  
7 Idaho Legislature, do hereby respectfully represent that:

8 WHEREAS, Alex J. Adams has served the State of Idaho with distinction in  
9 various roles, including as Administrator of the Division of Financial Management,  
10 Director of the Idaho Board of Pharmacy, and most recently as Director of the Idaho Department of Health and Welfare; and

12 WHEREAS, Mr. Adams has demonstrated a commitment to efficient and responsible government by providing critical leadership in budget management, health care policy, and administrative reform; and

15 WHEREAS, Mr. Adams's work has significantly contributed to greater transparency, innovation, and fiscal responsibility in Idaho state government; and

18 WHEREAS, Mr. Adams has been recognized for his professional integrity, collaborative leadership style, and deep understanding of both the technical and human aspects of public service; and

21 WHEREAS, Mr. Adams's efforts have significantly benefited Idaho's citizens and have laid the groundwork for Idaho's continued success with respect to state operations and governance; and

24 WHEREAS, President Donald J. Trump has nominated Mr. Adams to serve in his administration; and

26 WHEREAS, Mr. Adams's nomination is a testament to his professional accomplishments and demonstrates the value of Idaho's leadership role on the national stage; and

29 WHEREAS, the United States Senate is charged with the responsibility of providing advice and consent on executive appointments; and

Trump's administration, and urge the United States Senate to swiftly approve his nomination.
