Chairman Vander Woude called the meeting to order at 9:00 a.m.

MOTION: Rep. Thompson made a motion to approve the minutes of the January 8, 2025,

meeting. Motion carried by voice vote.

Chairman Vander Woude turned the gavel over to Vice Chairman Erickson.

Dr. Alex Adams, Director, Department of Health and Welfare (DHW), gave a synopsis of the DHW's improved direction, emphasis, and how Administrative Rule

changes will return decision making to Idaho lawmakers.

DOCKET NO. 16-0314-2401:

Jared Larsen, Legislative and Regulatory Affairs Chief, DHW, presented **Docket No. 16-0314-2401**, to repeal hospital licensing requirements which already exist in Title 39 Chapter 13 of Idaho Code. To be eligible for federal funding, hospitals must also be certified through The Centers for Medicare and Medicaid Services (CMS). The certification process is comprehensive and requires an on-site survey to ensure compliance, mirroring the Administrative Rule. Given this duplication, the department will pursue a legislative proposal in 2025 to consolidate the licensing process, using the CMS certification standards as the benchmark for obtaining a hospital license and deeming all licensed CMS hospitals also licensed in the state

of Idaho.

MOTION: Rep. Redman made a motion to approve Docket No. 16-0314-2401. Motion

carried by voice vote.

DOCKET NO. 16-0601-2402:

Jared Larsen, Legislative and Regulatory Affairs Chief, DHW, presented **Docket No. 16-0601-2402**, to extend this temporary Administrative Rule which addresses

crisis levels of need by allowing the DHW discretion in certain foster care situations.

Andrea Blackwood, Bureau Chief, Division of Child Welfare, DHW, was invited to answer questions. She stated this Administrative Rule assists foster care families who have large sibling groups or children with special needs. The incident notification prior to any placement on the Child Protection Central Registry includes a requirement for the DHW staff to provide documentation within fourteen days and a recipient response within twenty-eight days. As a closed registry, only verification of a listing on the registry is released. During this process a safety decision for the

child's placement is made in collaboration with the courts.

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative and Regulatory Affairs Chief, DHW, presented **Docket No. 16-0601-2403**. The DHW is requesting extension of this temporary and the contract of the con

Docket No. 16-0601-2403. The DHW is requesting extension of this temporary Administrative Rule to July 1, 2025. Changes include an enhanced definition for "kin" and waiver of adoption fees as specified. It does not require any additional

home study and simplifies adopting a child out of the state's custody.

situations where an older sibling might provide the best placement.

Answering a question, **Julie Subchek**, Program Manager, Child Welfare Division, stated the requirements for firearm and ammunition storage follows the extra level of safety provided in the national model. This prevents easy access for a child who

may be experiencing a mental health crisis.

parents a fast-track to re-enter the program.

Addressing committee concerns, **Julie Subchek** explained a returning family must

attest they have maintained conformity, including their household, to use the fast

track.

Rule which requires extension of its expiration date to July 1, 2025.

MOTION: Rep. Redman made a motion to approve Docket No. 16-0314-2301. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented Docket No. 16-0103-2401:

16-0103-2401, an Emergency Medical Services (EMS) Administrative Rule chapter

repeal. The information has been consolidated into pending Administrative Rule

Docket No. 16-0101-2401, which was approved on January 14, 2025.

MOTION: Rep. Redman made a motion to approve Docket No. 16-0103-2401. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented Docket No.

16-0212-2401: **16-0212-2401**, a Zero-Based Regulation (ZBR) rewrite for newborn screening.

Existing since 1921, the changes update and consolidate the language with no impact to the process. Duplications have been removed, addressing interpretive

modifications made when the rule was created.

Invited to answer questions, Dr. Marcia Witte, Division of Public Health, DHW, said the first screen is required within 24 to 48 hours after birth. There is no requirement for the mother and baby to remain in the hospital for the screening. No data has been collected to determine how many mothers and babies do remain in

the hospital for the screening.

A committee member expressed concern regarding the changes from "must" to "should" found in Sections 100 and 200 when Idaho Code states "must." Mr. Larsen explained the sections pertain to requirements for the department, not the hospitals or parents, and addresses technical non-compliance for items of lesser importance.

Rep. Fuhriman made a motion to approve Docket No. 16-0212-2401. Motion MOTION:

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No. 16-0213-2401**. a pending fee Administrative Rule for the Idaho Drinking Water

16-0213-2401, a pending fee Administrative Rule for the Idaho Drinking Water Laboratory Certification Program. This is a ZBR review with reorganized sections designed to enhance use. Not updated since 2011, the fee increases include the base fee per discipline and the base certification fee for out-of-state chemistry and microbiology laboratories. Laboratories performing microbiology testing now

have a simplified flat annual fee.

carried by voice vote.

policy change assures information transparency, allowing foster families to get the

information they need to be successful.

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No.**

16-0605-2401: 16-0605-2401, alleged medical neglect of disabled infants, to remove duplicative

rules found elsewhere and in statute.

MOTION: Rep. Redman made a motion to approve Docket No. 16-0605-2401. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket**

16-0418-2401: No. 16-0418-2401, a temporary and pending Administrative Rule for children's

agencies and residential licensing. The changes align with Idaho Code for foster care licensing and provide the DHW with the ability to make additional requirements

deemed necessary for the safety of the children.

MOTION: Rep. Redman made a motion to approve Docket No. 16-0418-2401. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No.**

16-0407-2401: 16-0407-2401, a chapter repeal for Idaho State Hospital North and State Hospital

South. This chapter was a duplication of the applicable waiver requirements and

authority.

MOTION: Rep. Cayler made a motion to approve Docket No. 16-0407-2401. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket 16-0717-2401: No. 16-0717-2401.** substance use disorders services. This rule prevents the

No. 16-0717-2401, substance use disorders services. This rule prevents the accumulation of costly, ineffective, and outdated regulations. The changes allow

certification from a national certifier, thus increasing the possible number of

providers.

Peyton Darst, representing the Idaho Behavioral Health Association, testified in support of **Docket No. 16-0717-2401**. The addition of national certification

increases reciprocity, keeps quality care standards alive, and addresses the

workforce shortage.

MOTION: Rep. Wheeler made a motion to approve Docket No. 16-0717-2401. Motion

carried by voice vote.

DOCKET NO. Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No.**

16-0733-2401: 16-0733-2401, adult mental health (MH) services. The changes remove those

items now included in the Magellan contract, moving the DHW from a position of

direct service provider to contractor of services.

Juliet Charron, Deputy Director, Medicaid and Behavioral Health (BH), DHW, was invited to answer questions. She clarified a public records request is needed to obtain a full copy of the Magellan contract. Participants and providers have access to copies through the DHW and Magellan websites. The DHW is still in the full oversight role to assure services are delivered appropriately and within Idaho policy and code. Moving personnel between the Medicaid and BH divisions has filled any staffing needs.

MOTION:

Rep. Rubel made a motion to **HOLD Docket No. 16-0733-2401** to time certain, February 12, 2025.

She expressed concern for both the contract included items within the rules and the removal of legislative participation in any new contract. Holding the rule for one month would insure safeguards for future contracts.

Ms. Charron stated the Administrative Rule addressed only the DHW staff roles. With the deletion of those roles, the rules have been updated. The services are reflected in both the Medicaid State Plan and Medicaid federal authority, which describes the DHW oversight role and the provider role of Magellan.

SUBSTITUTE MOTION:

Rep. Wheeler made a substitute motion to approve Docket No. 16-0733-2401. Motion carried by voice vote. Reps. Rubel and Egbert requested they be recorded as voting NAY.

DOCKET NO. 16-0737-2401:

Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No. 16-0737-2401**, Administrative Rule changes to remove the provider actions now being handled by a contracted service provider.

Treena Clark, Public Policy Manager, DHW, noted Idaho Code Title 16, Chapter 24 covers children's MH services and Title 39, Chapter 31 is for adult MH services.

MOTION:

Rep. Redman made a motion to approve Docket No. 16-0737-2401. Motion carried by voice vote.

DOCKET NO. 16-0313-2401:

Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No. 16-0313-2401**, a ZBR rewrite to eliminate outdated duplicative wording and streamline the chapter. There were no substantive changes.

MOTION:

Rep. Redman made a motion to approve **Docket No. 16-0313-2401. Motion** carried by voice vote.

DOCKET NO. 16-0309-2401:

Jared Larsen, Legislative & Regulatory Affairs Chief, DHW, presented **Docket No.** 16-0309-2401 for the Medicaid Basic Plan. The changes remove duplications with controlling federal regulations and provide the Idaho legislature the ability to make allowed policy changes. Also reflected is direction to the DHW to follow the legislative scope of practice decisions. Section 009 is not intended to trigger any background check reporting prior to an employer's knowledge of a crime having been committed.

MOTION:

Rep. Redman made a motion to approve Docket No. 16-0309-2401.

Ms. Charron, regarding the prosthetic and orthotic devices section, said it represents existing Idaho and Medicare policies. Applicable documentation will be updated and available to the public, if requested, prior to the rule's effective date.

Dr. Adams stated Medicaid covers the "what" and Idaho's legislature determines the "who." If the legislature creates a new "who," Medicaid automatically pertains to them.

VOTE ON MOTION:

Vice Chairman Erickson called for a vote on the motion to approve Docket No. 16-0309-2401. Motion carried by voice vote.

Vice Chairman Erickson turned the gavel over to Chairman Vander Woude.

Chairman Vander Woude turned the gavel over to Vice Chairman Erickson.

DOCKET NO. 24-0901-2401:

Cecely Metcalfe, Board Services Manager, Occupational License Bureau, Division of Occupational and Professional Licenses (DOPL), Executive Officer, Idaho Board of Examiners of Nursing Home Administrators, presented **Docket No. 24-0901-2401**, which has Zero Based Reduction (ZBR) driven changes. With the chapter reorganization, unnecessary, duplicate, and outdated language has been deleted or updated to simplify, clarify, and align the Administrative Rules with Idaho Code.

Answering questions, **Ms. Metcalfe** stated DOPL is moving to a twenty-four month renewal cycle and aligning the continuing education (CE) to the same cycle. The board's cash balance as of September 30, 2024, is (\$7,128.78). Negotiated rulemaking will be used to increase the fees to move within the required 30% to 125% of the five-year annual rolling expenses required by statute. Proposed legislation will combine this board with the Board of Examiners of Residential Care Facilities. This is anticipated to decrease expenses through staff consolidation. A new licensing system has been introduced and is expected to further reduce expenses. With CE requirements changed from annual to biennial, the board decided a CE carry over was no longer necessary.

MOTION: Rep. Healey made a motion to approve Docket No. 24-0901-2401. Motion

carried by voice vote.

DOCKET NO. Cecely Metcalfe, Board Services Manager, Occupational License Bureau, DOPL, Executive Officer, Idaho Board of Examiners of Residential Care Facility

Administrators, presented **Docket No. 24-1901-2401**. This ZBR chapter rewrite reorganizes chapters, adds a new licensure pathway for individuals holding a Health Services Executive credential, changes the CE cycle to biennial, expands the type of CE courses, aligns examinations with Idaho Code, removes duplication, increases fees to align with Idaho Code, and removes civil fines due to lack of

statutory authority.

Ms. Metcalfe, in response to questions, said the board's cash balance, as of September 30, 2024, is (\$9,271.24). It is anticipated this board will be part of the consolidation within the proposed legislation previously mentioned. Efficiencies and possibly raising fees further in alignment with statutory authority are first steps to get the board in line with Idaho Code. There are 440 individuals licensed through the Residential Care Examiners Board. The fee changes will put the board at 31% by the end of Fiscal Year 2028. Responding to concern expressed when combining two boards with negative balances, she explained the importance of making the reductions and changes without impacting the workforce or patient safety. The boards, if allowed to combine, are expected to have a positive balance within three years.

MOTION:

Rep. Fuhriman made a motion to approve Docket No. 24-1901-2401.

SUBSTITUTE MOTION:

Rep. Vander Woude made a substitute motion to **HOLD Docket No. 24-1901-2401**, stating he is not in favor of approving the rule without a review of how it became negative and a plan to remove the board from such a large negative

This ZBR rewrite reorganizes chapters, removes duplication with Idaho Code or national certification requirements, and eliminates the inactive status licensure requirements which are not within the board's statutory authority. Provision is made for consideration of other licensing exams, if available.

Upon questioning, **Ms. Metcalfe** relayed the cash balance of this board, as of September 30, 2024, is \$143,548.51, which is 373%. The board has reduced fees by 20%, effective January 1, 2025. Inactive status is no longer an option since only three individuals have ever made requests. The language "not to exceed" within the fee table allows the board to actively reduce fees.

Docket No. 24-3601-2402, a zero-based regulation (ZBR) chapter rewrite. The chapter has been reorganized, with duplicate and obsolete sections removed or updated. The fees were capped at the current legislative approved rates. The drug outlet updates simplify reporting requirements. The annual inventory was changed to biennial and remains consistent with federal requirements. Criminal conviction reporting was changed from upon license renewal to thirty days of the incident. The compounding exemptions were updated and include coloring agents. Sterile preparation incorporates current terminology to better reflect the standard of care.

MOTION: Rep. Redman made a motion to approve Docket No. 24-3601-2402, with the

exception of Section 200.14.e. Motion carried by voice vote.

Duplicate licensure requirements and definitions were removed. Other changes align with statute, replace "scope of practice" with "practice standards," and clarify references. Reinstatement and inactive license fees were removed in alignment with the Division's authority.

Answering a question, **Ms. Chopski** said the specific exam supplier's name was added as required by Idaho Code. As the only PA examiner option, not listing them

would place the rule in violation of statute.

MOTION: Rep. Redman made a motion to approve Docket No. 24-3302-2401, with the

exception of Section 100.01. He expressed his concerns regarding information on the examiner's website indicating their diversity and inclusion (DEI) operating

beliefs.

When asked about the board's cash balance, **Ms. Chopski** said as of fiscal year 2024, the balance was \$215,356.11, 146% of operating expenses. A recent 15.5% fee reduction recommendation to the Board of Medicine will be reviewed at their

next meeting. There are no other agencies available to certify PAs.

SUBSTITUTE MOTION:

Rep. McCann made a substitute motion to approve Docket No. 24-3302-2401.

Committee discussion included the extreme costs related to creating an Idaho-specific exam, the functionality of not including the examiner company's name, the growing trend away from DEI nomenclatures on websites, and the impact of an Idaho declaration of non-support for DEI statements.

The substitute motion voice vote was unclear. Vice Chairman Erickson requested a roll call vote. Substitute motion failed by a vote of 7 AYE and 8 NAY. Voting in favor of the substitute motion: Reps. The CE has been simplified to allow any germane course. Fees have been consolidated from two fee tables for clarity. The inactive renewal fee has been removed. Answering a question, he said the board, as of FY 2024, has a cash balance of \$186,793.63, 117% of their operating budget.

Executive 24-3304-2401: Officer, Allied Health Advisory Board, presented **Docket No. 24-3304-2401**. Changes were made to be consistent with the DOPL board format. The inactive license fee was eliminated. MOTION: Rep. Redman made a motion to approve Docket No. 24-3304-2401. Motion carried by voice vote. DOCKET NO. John Price, Bureau Chief, Occupational Licensing Bureau, DOPL, presented Docket No. 24-0301-2401, a chapter rewrite in alignment with ZBR requirements. 24-0301-2401: In this rewrite, chapters were reorganized, and duplications of Idaho Code were removed. The word "college" was replaced with "program" to recognize all accredited institutions. Other changes allow for qualified international applicants and other competency exams. CE requirements were updated to the two-year model. Inactive license was updated to a biennial issuance, increasing the maximum number of conversion years. Rewording assures chiropractic assistants do not provide treatment advice. Stipulation was made regarding advertisements claiming affiliation with a research project. Sexual misconduct was clarified to include sexual misconduct against a spouse. MOTION: Rep. Rasor made a motion to approve Docket No. 24-0301-2401. Motion carried by voice vote. expansion.

Responding to questions, **Rep. Vander Woude** stated restoration or development of catastrophic or indigent funds can be evaluated should this proposed legislation

be approved.

Concern was expressed by committee members regarding the consequential costs of this repeal. This proposed legislation is in opposition to the wishes of Idaho

voters. An economic outlook for the repeal consequences was suggested.

Rep. Vander Woude, responding further, said the program costs, which were originally stated to be \$32M, are now at \$110M. A closer look at the programs, funding, and causes for the increase is needed. It is possible the federal

government may decrease the 90/10 split to the standard 70/30 split. This would

increase the Idaho portion by another \$2M.

VOTE ON MOTION:

Vice Chairman Erickson called for a vote on the motion to introduce RS 31896.

Motion carried by voice vote. Reps. Rubel and Egbert requested they be

recorded as voting NAY.

Vice Chairman Erickson turned the gavel over to Chairman Vander Woude.

RS 31973: Rep. Bruce Skaug, District 10, presented RS 31973, the Medical Ethics Defense

Act, which protects moral or ethical beliefs. Through this protection for the health

care industry, it is anticipated workers will enter the field.

RS 31958: Rep. Josh Wheeler, District 35, presented RS 31958. This proposed legislation for

Chairman Vander Woude turned the gavel over to Vice Chairman Erickson.

RS 31996: Rep. John Vander Woude, District 22, presented RS 31996, proposed legislation

to change the Medicaid value-based payment agreement dates from January through December to Idaho's fiscal year of July 1 through June 30. This will improve the legislature's ability to review performance of the contracts. Answering

a question he said the existing contracts would have a six-month carry over.

MOTION: Rep. Redman made a motion to introduce RS 31996. Motion carried by voice

vote.

Vice Chairman Erickson turned the gavel over to Chairman Vander Woude.

RS 32064: Rep. Jordan Redman, District 3, presented RS 32064, creating a three-year

physician license to expand the current physician bridge-year program.

MOTION: Rep. Healey made a motion to introduce RS 32064. Motion carried by voice vote.

Pat Kelley, Executive Director, Your Health Idaho (YHI), presented their annual

report.

With 120,000 Idahoans enrolled, YHI experienced their highest customer retention. Of the enrollees, 68% are renewals and 32% are new customers. Agents or brokers were used for 71% of the enrollments. Income sources include the assessment fee,

building rent, and cash reserve interest.

Improvements include implementing an affordability calculator, enrollment counselors in community centers, and targeted campaigns to increase brand and

option awareness.

Future efforts will focus on partnerships, teams, education, and continuation of the existing fiscal conservative business principles. YHI has the lowest operating costs of all state-based exchanges and one of the highest per capita enrollment rates.

Responding to questions, **Mr. Kelley** explained states without Medicaid expansion have a federal poverty level (FPL) of 100%, as opposed to Idaho's FPL of 139%. Tax credits are being utilized by 120,000 Idahoans. People leave the exchange for a variety of reasons, including Medicare eligibility and employment coverage. The United States Treasury pays the tax credits directly to the insurance companies. YHI uses three primary releases to assure their technology remains up to date,

avoiding the costs and time of a large refresh.
