Chairman Crane (13) introduced the new House State Affairs Page, **Ella Thompson** and Committee Secretary **Liaza Richardson**. Chairman Crane (13) explained the committee rules.
RS 31836: **Rep. Scott** presented **RS 31836** and explained the background and the purpose of the proposed resolution is to reaffirm the states authority to regulate marriage. It encourages the Supreme Court to revisit **Obergefell vs Hodges** and request reconsideration and the purpose to restore federalism.
