13 Be It Enacted by the Legislature of the State of Idaho:

14 SECTION 1. IDAHO CODE CLEANUP -- LEGISLATIVE INTENT. It is the intent
15 of the Legislature to ensure that the state laws provided in Idaho Code are
16 streamlined, up-to-date, and essential for the citizens of Idaho, while best
17 serving the public health, safety, and welfare. In accordance with the Idaho
18 Code Cleanup Act, following comprehensive review, the Legislature has iden-
19 tified the provisions of this act as obsolete, outdated, or unnecessary.

20 SECTION 2. That the Heading for Chapter 8, Title 38, Idaho Code, be, and
21 the same is hereby amended to read as follows:

22 CHAPTER 8
23 FLOATING TIMBER

24 SECTION 3. That Section [38-802](#), Idaho Code, be, and the same is hereby
25 repealed.

26 SECTION 4. That Section [38-803](#), Idaho Code, be, and the same is hereby
27 repealed.

28 SECTION 5. That Section [38-804](#), Idaho Code, be, and the same is hereby
29 repealed.

30 SECTION 6. That Section [38-805](#), Idaho Code, be, and the same is hereby
31 repealed.

32 SECTION 7. That Section [38-806](#), Idaho Code, be, and the same is hereby
33 repealed.

34 SECTION 8. That Section [38-807](#), Idaho Code, be, and the same is hereby
35 repealed.

1 SECTION 9. That Section [38-1210](#), Idaho Code, be, and the same is hereby
2 repealed.

3 SECTION 10. That Chapter 8, Title 58, Idaho Code, be, and the same is
4 hereby repealed.

5 SECTION 11. An emergency existing therefor, which emergency is hereby
6 declared to exist, this act shall be in full force and effect on and after
7 July 1, 2026.
