<a href="#"><u>RS 32894</u></a>	The Legislature approved the Idaho Code Cleanup Act in 2025. Submitted sections of the Idaho Code were reviewed for repeal consideration by the DOGE Task Force on the criteria of obsolete, outdated and unnecessary.	Sen. Lakey
<a href="#"><u>RS 32896</u></a>	This legislation updates a time zone reference in Section 20-524A, Idaho Code by removing the word standard from "mountain standard time."	Sen. Lakey
<a href="#"><u>RS 32993</u></a>	This legislation will exempt photographs or images of decedent individuals from public disclosure.	Sen. Wintrow
<a href="#"><u>RS 33120</u></a>	This legislation makes it clear that statutorily the Attorney General's office has the ability to pursue a declaratory action or seek injunctive relief through the courts to civilly enforce the provisions of Idaho Code.	Sen. Lakey
<a href="#"><u>S 1232</u></a>	CRIME VICTIMS - Repeals and adds to existing law to establish provisions regarding proceeds derived from criminal notoriety.	Sen. Nichols
<a href="#"><u>S 1233</u></a>	CONSTITUTIONAL COURTS ACT - Adds to existing law to provide that no state court shall enforce, consider, or apply any judgment, decree, ruling, or decision of arbitration based on certain forms of religious or cultural law.	Sen. Foreman
